Introduction

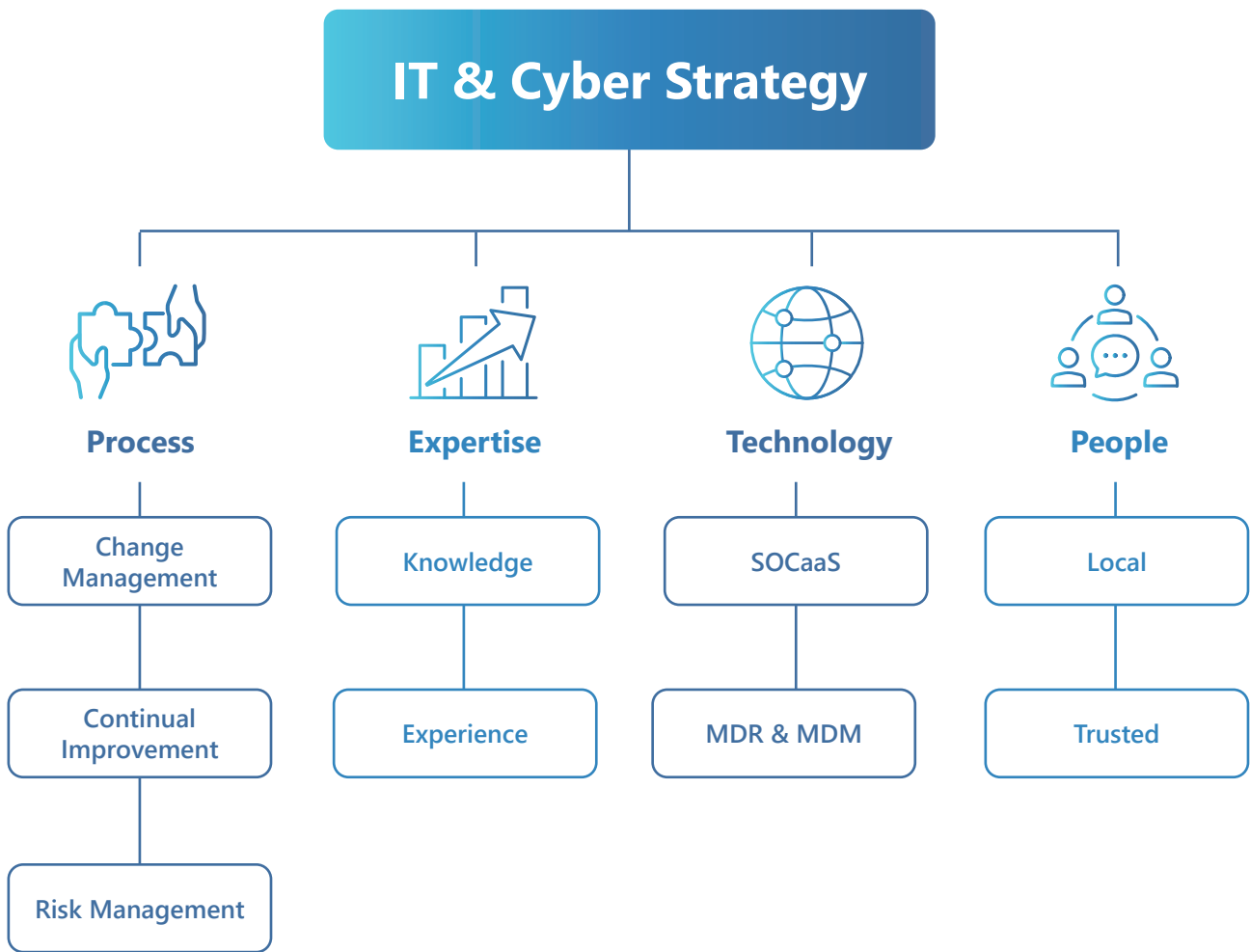
